

# Golf Carts

1. Golf Carts will be allowed for the 2012 season the requirements are:

- A) Golf Cart Registration Fee of \$25.00 paid to Office
- B) Gasoline powered only.
- C) Golf carts need to have fixed headlight(s) and reflectors in order to be driven after dark.
- D) Proof of liability insurance with a minimum coverage of \$100,000.00. (This can easily be added to your homeowners or RV insurance policy) A signed "Golf Cart Agreement & Inspection by Office.
- E) All golf carts must be maintained in good working order. Management reserves the right to refuse registration to carts that are deemed unsafe.
- F) Site numbers must be clearly displayed on both sides of your cart in 3" or larger numbers/letters.
- G) All operators of a golf cart must be 21 and have in his/her possession a valid driver's license. It is the golf cart owner's responsibility to ensure that anyone without a valid driver's license does not operate your golf cart.
- H) Operating a golf cart while under the influence of alcohol is strictly forbidden. Violation will result in revocation of permit and privilege to operate a golf cart at Lazy Days Campground.
- I) Passengers are limited to the number of seats on the golf cart.
- J) Absolutely no minors are allowed to drive Golf Carts or drive a cart while on the lap of an adult. All minors are to be secured and under adult control while in your cart.
- K) Carts are to be operated in a safe and responsible manner at all times. Stay on common roads at all times and abide by all posted speed limits.
- L) A copy of these rules must be signed by all golf cart owners, which will be kept on file with a Copy of the insurance card and registration information (below).  
In addition, you hereby release, indemnify and hold Lazy Days Campground, Inc., its officers and employees harmless from any action resulting from the use of the registered golf cart.

Failure to abide by any of the foregoing operational rules or Lazy Days Campground rules shall be penalized as follows:  
Revocation of permit and privilege to operate golf cart at the park.
